All Sustainable Meeting Planning Program® (SMPP®) users may self-certify that they are implementing the SMPP® system and are complying with the ISO 20121 Event Sustainability Management System standard and APEX/ASTM Standards for Environmentally Sustainable Meetings, Events, Trade Shows and Conferences level 1 planner requirements. SMPP® users may attach the SMPP® letters and logo to their name and organization with the ® symbol.

In addition, iCompli, a division of BPA Worldwide, offers an independent third-party certification program to ISO 20121 for SMPP® system users. iCompli has prequalified the SMPP® system and certified it to meet and exceed the ISO 20121 standard. iCompli verifies that a business or individual is using the SMPP® system to comply with ISO 20121 and has demonstrated the ability to plan meetings and events in compliance with ISO 20121 international standard for Event Sustainability Management Systems.

How it works:

The SMPP® team coaches your event planning team through a series of 13 steps with emails and calls. We prepare your first draft of all the documentation listed below at every step until you become certified to ISO

20121 by iCompli. Your initial ISO 20121 certification from iCompli will audit and certify both your organization as well as your initial Designated Event. Our 13-step process consists of:

- 1. Adopt the SMPP® policies and procedures.
- 2. Prepare your sustainability memo and employee compliance memo.

- 4. Prepare your initial annual management plan.
- 5. Conduct your ISO 20121 required training.

Phase 2: Designated Event SMPP® System Implementation
